ORDER

In the Interim Order dated 08.12.2025 in IA No.1/2025 and IA No.2/2025 in WP(C) No.42316/2025 filed by TRDCL before the Hon’ble High Court of Kerala, the Court directed the respondents to release the annuity amount withheld from the payment due to TRDCL, subject to further orders of the Hon’ble Court.

2. The Chief Executive Officer, Kerala Road Fund Board as per the letter read as 2nd above has reported that an amount of ₹4.508 crore was deducted from the 26th annuity payment to TRDCL based on the Audit Report of the Accountant General dated 03.12.2021 and requested Government to allot the said amount to KRFB for releasing the payment to TRDCL in compliance with the Interim Order of the Hon’ble High Court.

3. Government examined the matter in detail and are pleased to accord sanction to release an amount of ₹4.508 crore (Rupees Four Crore Fifty Lakh and Eighty Thousand only) from the Head of Account 3054-80-800-92 to the Kerala Road Fund Board (KRFB) for payment to TRDCL, in compliance with the Interim Order dated 08.12.2025 of the Hon’ble High Court in WP(C) No.42316/2025 subject to the further orders of the Hon’ble High Court.
