- iii) The Director, RCC shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in G.O.(MS)No. 4/2020/Fin dated 09/01/2020.
- iv) If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
