In the Budget Estimates for 2024-25, an amount of Rs.27.60 crore was provided to e Health / SDHM under the Head of Account 2210-01-001-88(P). As per the Government Order read as paper 1st above, Administrative Sanction was accorded for the utilization of Rs.465.91 lakh for the implementation of the scheme "Kerala Digital Health Mission - e Health Programme".
