**ORDER**

As per Judgment read as 1<sup>st</sup> paper above, the Hon'ble Supreme Court in S.M.W. (Crl.)No.1/2019 ordered for the creation of additional force in the Police Department under the POCSO Act, 2012 for timely investigation, trial and related activities including rehabilitation of survivors of POCSO cases.

2. On the basis of the decision taken in the meeting held by the Hon'ble Chief Minister on 05.10.2021, a Committee comprising the Additional Chief Secretary of the Home Department, the Additional Chief Secretary of the Finance Department, the Secretary of the Law Department, the Secretary of the Social Justice Department and the

State Police Chief was constituted as per Government Order read as 2<sup>nd</sup> paper above. The committee considered the matter and recommended the Government to approve the proposal in principle.

3. Subsequently, as per letter read as 3<sup>rd</sup> paper above, the State Police Chief submitted a proposal to the Government regarding creation of 304 posts in the Police Department in connection with the formation of a Special Investigation Team, as follows:-

4. Government have examined the proposal submitted by the State Police Chief in detail and are pleased to accord sanction to create 304 posts of Police personnel in the Police Department, as mentioned in para 3 herein above for effective investigation of POCSO cases in a time bound manner.
