Government, as per the letter read as 1 st paper above have accorded revalidated Administrative Sanction for an amount of Rs. 367 Lakh for the Modernisation project of Autokast Ltd, during 2024-25.

2) As per the letter read as 2 nd paper above the Executive Chairman, Board for Public Sector Transformation has furnished the proposal for the revalidation of Administrative Sanction for the above said project for an amount of Rs. 500 Lakh during 2025-26.

3) Aims and Objectives of the project:- The project is a continuing scheme and is very essential to reduce the plant breakdown.

- d. Stores purchase rules shall be strictly adhered to wherever applicable.
- e. Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- f. Post creation and purchase of vehicles are not admissible under the scheme.
