ORDER

As per Government Orders cited above , a total amount of Rs.402.50 lakh was released to the Kerala Rural Water Supply and Sanitation Agency (Jalanidhi) from the budget provision of Rs.1150 lakh earmarked under the Head of Account 2215-01-800-64(P) for the implementation of the scheme "Scaling up of Rain Water Harvesting and Ground Water Recharge Programme" during the financial year 2025-26

2. The Executive Director, Jalanidhi, vide letter cited , has informed that out of the released fund , an amount of ₹401.83 lakh was incurred as expenditure leaving an amount of ₹66,607/- in the PSTSB Account of Jalanidhi which was resumed by Government on 31.03.2026 . Hence, he has requested to release the resumed fund of ₹66,607/- for the settlement of pending bills under the Scheme.

3. An amount of Rs.1200 lakh has been earmarked under the

Head of Account "2215-01-800-64(P)-Scaling up of Rain Water Harvesting and Ground Water Recharge Programme" for the financial year 2026-27.

Government have examined the matter in detail and are pleased to accord sanction for reallocation and release of the resumed amount of ₹66,607/- (Rupees Sixty Six Thousand Six Hundred and Seven only) from the current year's budget provision under the Head of Account "2215-01-800-64(P) -Scaling up of Rain Water Harvesting and Ground Water Recharge Programme" .
