### ORDER

The Viksit Bharat - Guarantee for Rozgar and Ajeevika Mission (Gramin) [VB-G RAM (G)] Act, 2025 aims to align rural development with the national vision of Viksit Bharat @2047 by guaranteeing one hundred and twenty-five days of wage employment each financial year to rural households whose adult members volunteer for unskilled manual work. Furthermore, it seeks to build a prosperous and resilient rural India through the creation of a National Rural Infrastructure Stack, modernized digital governance, and comprehensive, saturation-driven planning. As per the Gazette notifications, read as 2<sup>nd</sup> paper above, it has been decided to repeal the prevailing employment guarantee scheme (MGNREGS) and bring the new VB-GRAM G Act into force in the country from July 1, 2026. Hence, the Mission Director, MGNREGS has recommended the formation of a State Level Steering Committee for the State-level implementation of the newly formed VB-G RAM G scheme as per section 15 of the Act.

2) Government have examined the matter in detail and are pleased to constitute a State Level Steering Committee with the following composition; for the monitoring and co-ordination of VB-G RAM G Act,
