ORDER

As per the letter read as 1st paper above, the State Police Chief has requested to allot adequate fund amounting to Rs.85,61,12,500/- to Police Department across various heads of account to meet the expenditure in connection with the Kerala Legislative Assembly Election 2026. Subsequently Government have allotted a total amount of Rs.60,99,50,000/- to the Police Department under the Head of Account 2015 Elections-106-99-NV to meet the election related expenditure as per Government Orders read as 2nd to 5th papers above. Later as per the letter read as 6th paper above, the State Police Chief has informed that the current allotment is insufficient to cover the Special DA and feeding charges/honorarium for personnel deployed for counting related duty. The State Police Chief has therefore

requested to allot an additional amount of Rs.8,80,00,000/- under head of account 2015-106-99-04-01 Tour TA and Rs.4,50,00,000/- under the head of account 2015-106-99-34-Other Charges-3 Other Items to cover the election related expenditures especially for counting day duties for the General Election to the Kerala Legislative Assembly 2026.

2) Government have examined the matter in detail and are pleased to accord administrative sanction for an amount of Rs.8,80,00,000/- (Rupees Eight Crore Eighty Lakh Only) under the head of account 2015-00-106-99-04-01-Tour TA and Rs.4,50,00,000/- (Rupees Four Crore Fifty Lakh Only) under the head of account 2015-00-106-99-34-03-OC to meet the expenditure in connection with counting related duty for the General Election to KLA 2026, subject to the condition that no more amount over the amount already sanctioned for election purpose will not be allowed under other head of accounts.

3) The said amount of Rs.8,80,00,000/- (Rupees Eight Crore Eighty Lakh Only) under the head of account 2015-00-106-99-04-01-Tour TA and Rs.4,50,00,000/- (Rupees Four Crore Fifty Lakh Only) under the head of account 2015-00-106-99-34-03-OC has been additionally authorised as per Government Order read as 7th paper above.
