### ORDER

As per the letters read as 1st paper above, an amount of ₹2,03,00,000/- (Rupees Two Crores Three Lakh only) was released by Ministry of Tribal Affairs(MoTA), Govt. of India, in the form of Mother Sanction , towards creation of capital assets under Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) during the financial year, 2026-27 for the purpose of setting up of **15 Multi Purpose Centres (MPCs)** (at the unit cost upto Rs.60 lakh subject to cost arrived as per transparent process with due procedure for arriving at the cost), as follows:
