ORDER

As per the Government Order referred as 1st above, a Technical Resource Centre (TRC) was constituted to manage and implement various activities of KKEM. Subsequently, the Technical Resource Centre was established through the Centre for Management Development (CMD) for the speedy implementation of the Kerala Knowledge Economy Mission (KKEM). The Technical Resource Centre is also monitoring the activities of the Kerala Medical Technology Consortium (KMTC) and the Kerala Genome Data Centre of K-DISC. The CMD has also been entrusted with the task of monitoring the PMU of Climate Smart Coffee Programme of K-DISC.

2. In the Government Order cited as 2nd above, the Government have declared the Centre for Management Development (CMD) as a partner

institution of K-DISC for implementing projects under various State Plan schemes of K-DISC with retrospective effect from 01.11.2022. Also, sanction has been accorded to release State Plan Fund on request to the Centre for Management Development (CMD) for implementing State Plan schemes of K-DISC, being considered as a partner institution.

- 3. In the Government Order referred as 3rd above, Administrative Sanction has been accorded for the Annual Plan Schemes of K-DISC for the current financial year 2024-25, viz., Innovation Challenge Fund and Knowledge Economy Fund including all spill over activities/programmes for the previous financial years.
- 4. As per the letter read as 5th above, the Member Secretary, K-DISC has requested to accord sanction to transfer credit of an amount of ₹63,73,393/- (Rupees Sixty-Three Lakh Seventy-Three Thousand Three Hundred and Ninety-Three Only) to the bank account of the Centre for Management Development (CMD) towards the Manpower Cost of officials of Technical Resource Centre (KKEM, KMTC & KGDC) and PMU of Climate Smart Coffee Programme including administration cost incurred for the month of September 2024 as detailed in table-1 below.
