ORDER

The Hon'ble Kerala Administrative Tribunal as per the order read as 3rd paper above, disposed the O.A 1296/2021 filed by Sri. A.C. Muraleedharan Nair, Range Forest Officer (Rtd), directing the respondent 1, Secretary, Forest and Wildlife Department and the respondent 2, Additional Principal Chief Forest Conservator, to consider and pass appropriate orders on Annexures Al and A2 representations respectively, in accordance with law, within a period of two months from the date of receipt of a certified copy of this order.

2. As per letter dated 04.02.2020 (Annexure A1) read as 1st paper above, the Additional Principal Chief Forest Conservator(Admin), had submitted proposal for extending the probation period of the Applicant. Sri. A.C Muraleedharan Nair had submitted representation (Annexure A2) before the Chief Forest Conservator read as 2nd paper above, requesting to take steps

for disbursement of his pensionary benefits.

- 3. Based on examination of the the Annexure A1 letter, Government had returned the proposal, directing the Additional Principal Chief Forest Conservator (Administration), to correct the proceedings of the Chief Forest Conservator, High Range Circle in which the probation period of Sri. A.C Muraleedharan Nair is extended for one year. The Additional Principal Chief Forest Conservator (Administration) as per letter dated 3.9.2021, read as 1st paper above, has furnished proposal with corrected proceedings as directed. Government as per order read as 4 th paper above, has extended the probation period of Sri. A.C Muraleedharan Nair from 01.03.2004 to 02.04.2010.
- 4. Government have examined the order of the Hon'ble Kerala Administrative Tribunal in detail and are pleased to direct, the Additional Principal Chief Forest Conservator(Administration) to declare the probation in respect of SriA.C Muraleedharan Nair wef 1.4.2010 and to sanction the pensionary benefits to him within the stipulated time limit.
- 5) The Order of Hon'ble Kerala Administrative Tribunal, read as 3rd paper above, is complied with accordingly.
