## **ORDER**

The Flag Officer, Commanding-in-Chief, Southern Naval Command had proposed an insurance cover for the Navy divers whilst rendering diving assistance to civil authorities. In this regard Member Secretary, KSDMA has submitted an Insurance coverage proposal of New India Assurance Company Ltd, according to which the quoted amount is ₹1,18,000/- (including GST) as the premium for coverage of 10 unnamed divers. Coverage includes death, permanent total disability, and permanent partial disability, with a standard medical extension of ₹10,000/- per person. The total coverage amount is ₹50 Lakh per person.

State Executive Committee of KSDMA held on 31/01/2025 considered the proposal and decided to sanction an amount of Rs. 1,18,000/-(including GST) under SDRF to provide insurance coverage to 10 unnamed divers under the Navy and also to extend a similar insurance coverage to divers attached to State Government, including Fire & Rescue Services.

Government have examined the matter in detail and are pleased to
