2) The objectives of the project are:

- To renovate and strengthen the existing dilapidated hostel building and ensure structural safety.
- To provide safe, hygienic and comparable residential environment for students.
- To upgrade roofing, flooring, water supply, sanitation and electrical systems to present-day standards.
- To improve academic support spaces such as study rooms, library and laboratories housed within the hostel block.
