ORDER

As per order read above Government had accorded Administrative Sanction for the purchase of a Mahindra Bolero Maxx Pup City LX CBC 1.3 BS-VI utility vehicle for the High Court at a cost of ₹7,50,000/-. There after as per letter read above the Registrar General informed that on re examining the matter the High Court decided to procure an '**Ashok Leyland Dost XL RLX FSD (with AC cabin)**' vehicle for transportation and shifting of goods of the High Court. The said vehicle is listed in the GeM portal at a base price of ₹6,83,293/- and further added that even after factoring in price variations and freight charges, the anticipated cost of the vehicle comes with in the sanctioned limit of ₹7,50,000/-. Hence, it is requested to accord revised Administrative Sanction and allocation of sufficient funds of 7,50,000/- (Rupees Seven Lakh Fifty Thousand Only) for the purchase of an '**Ashok Leyland Dost XL RLX FSD (with AC cabin)**' vehicle through the GeM portal, under the head of account: "2014-Administration of Justice 102-High Court-99-High Court-21-Motor

Vehicles -1- Purchase of Vehicles (Non-Plan -- Charged)".
