### ORDER

The Director of Fisheries as per the letter read as 1st above furnished Project Proposal of PRATHIBHATHEERAM – Establishing E-Learning and teaching facilities in certain selected coastal libraries for fishermen school students for a total outlay of Rs. 133.76250 lakh and has requested to accord sanction for the same.

2) 'Prathibhatheeram' is a proposal to enhance social progress and individual character and knowledge development in fishermen students to overcome educational backwardness of students from coastal area. 'Prathibhatheeram' aims to introduce new learning centres outside the school in a local library with all facilities of school class room along with computer, internet and allied equipments to develop knowledge and individual skills.

3) The objectives of the project is as follows:

- Centralizing the facilities at the grass root level and developing individual learning activities for each student.
- Establishing centres of e-learning, information technology, online courses and network systems.
- Promote the importance of practical knowledge and liberal thinking among students moulding them into disciplined social being.

- Establish higher psychological health and incur in them good behavioural spirit thus refraining them from drugs and substance use.
