ORDER

Vide Government Order read as the 1st paper above, an amount of ₹27,65,20,000/- had been sanctioned as the third installment towards the acquisition of land for the development of RESA at the Calicut International Airport to the Special Deputy Collector, Land Acquisition (Kozhikode Airport) under the head of account 5053-02-190-93-Land Acquisition for the Development of Kozhikode Airport (Plan-Voted).

- 2. Vide letter read as the 2nd paper above, the District Collector, Malappuram, informed that out of the allocated amount, ₹23,97,48,836/-was transferred to the accounts of beneficiaries in time. However, the remaining ₹3,67,71,164/- could not be utilized in the financial year 2023-2024 due to technical issues and has requested to release the same in the current financial year.
- 3. As per Government Order read as the 3rd paper above, an additional amount of ₹3,67,72,000/- (Rupees Three Crores Sixty-Seven Lakhs Seventy Two Thousand Only) has been authorized for the above

under the head of account 5053-02-190-93 - Land Acquisition for the Development of Kozhikode Airport (Plan-Voted).

4. The Government has examined the proposal in detail and are pleased to release an amount of ₹3,67,71,164/- (Rupees Three Crores Sixty Seven Lakhs Seventy One Thousand One Hundred Sixty Four) for the expenditure related to the development of RESA at the Calicut International Airport to the Special Deputy Collector, Land Acquisition (Kozhikode Airport) under the head of account 5053-02-190-93 - Land Acquisition for the Development of Kozhikode Airport (Plan-Voted).
