“MERIT SCHOLARSHIP SCHEME (2024-25)”

SCHOLARSHIPS FOR HIGH SCHOOL STUDENTS

I. Background

Kerala State Welfare Corporation for Forward Communities Limited is a Government of Kerala undertaking established for the comprehensive development of economically weaker sections among the forward communities in Kerala. During the financial year (2024-25), KSWCFC will continue the scholarship scheme to students belonging to economically weaker families of forward communities who undergo their education at High School level in Government/ Aided educational institutions in Kerala.

II. Scope of the Scheme

Scholarships will be provided to the students belonging to economically weaker sections among forward communities in Kerala for undergoing High School education in Government/ Aided educational institutions in Kerala.

III. Implementing Agency

Kerala State Welfare Corporation for Forward Communities Limited is the nodal agency for implementing the scheme. The scheme will be notified through Print and Electronic Media.

IV. Rate & No. of Scholarships

The rate of scholarships amounts to Rs. 2,500/- per annum for 2823 beneficiaries.

V. Eligibility

- (I) Students belonging to forward communities in Kerala (who do not come under the purview of reservation scheme operated by Government of India or State Government and who are not listed under Backward Classes, Scheduled Classes and Scheduled Tribes and Other Eligible Categories) shall be eligible.
- (II) Students belonging to the aforesaid category who are studying in High School in Government/ Aided educational institutions in Kerala shall be eligible.
- (III) Students who are availing similar scholarships or stipends from Central or State Government or any other body except e-grantz shall not be eligible.
- (IV) Students who have secured at least 70% marks in aggregate in the previous annual examination shall be eligible.

- (V) Annual family income shall not exceed Rs. 4 lakh. Annual family Income certificate should be in the name of a person included in the ration card containing the applicant.
- (VI) Annual family Income Certificate obtained from Village Officer & Caste certificate issued by village officer should be produced.
- (VII) Name of the student should be included in the ration card produced. The decision of the KSWCFC with regard to providing financial assistance shall be final.

VI. Selection Procedure

The Scheme will be advertised in the print and electronic media, primarily in the website of the Corporation (www.kswcfc.org) giving summarized information. The students, after assessing their eligibility and suitability, in accordance with the conditions, shall apply online via www.kswcfc.org in the form prescribed, before the stipulated date for receiving online application. Thereafter, all applications received up to the last date will be scrutinized by the Kerala State Welfare Corporation for Forward Communities Limited. The beneficiaries will be selected on the basis of their annual family income ie; by giving priority to lower income. Scholarship will be provided to the students belonging to economically weaker sections among forward communities in Kerala for undergoing Higher Secondary or equivalent courses in Government/Aided educational institutions in Kerala.

Kerala State Welfare Corporation for Forward Communities Limited is the nodal agency for implementing the scheme. The scheme will be notified through Print and Electronic Media.

Many of the youth belonging to the aforesaid communities are undergoing technical/vocational diploma courses offered by various educational institutions recognized by Government. Considering the scope and potential available to the qualified diploma holders, in the field of industry, health care or IT fields, KSWCFC Limited had launched the scheme to provide Scholarships to those who undergo Diploma/ Certificate courses in Government / Govt. approved institutions in Kerala from the year 2014-15 onwards.

II. Scope of the Scheme

The scheme covers all technical/vocational education under the diploma/certificate courses offered by Government / Govt. approved authorities in Kerala.

III. Implementing Agency

Kerala State Welfare Corporation for Forward Communities Limited is the nodal agency for implementing the scheme. The scheme will be notified through Print and Electronic Media.

IV. The Scheme

The scheme provides Scholarships to the selected students belonging to the economically weaker sections among forward communities in Kerala for undergoing diploma/certificate courses in Government / Govt. approved institutions in Kerala.

V. Rate & No. of Scholarships

The Scholarship amount will be Rs. 6,000/- annum to 635 beneficiaries.

- i. Students belonging to forward communities in Kerala below 25 (Twenty Five) years of age, as on the date of advertisement of the scheme (who do not come under the purview of any of the reservation scheme operated by Government of India or State Government and who are not listed under Backward Classes, Scheduled Classes and Scheduled Tribes and Other Eligible Categories) shall be eligible.
- ii. Students belonging to the aforesaid category who have been admitted to a diploma course in an educational institution duly recognized by the Government/competent authority shall be eligible.
- iii. Students who are availing similar scholarships or stipends from Central or State Government or any other body except e-grantz shall not be eligible.
- iv. Students doing regular and full time courses in an educational institution duly recognized by the Government/competent authority shall be eligible.
- v. Annual family income shall not exceed Rs. 4 lakh. Annual family Income certificate should be in the name of a person included in the ration card containing the applicant.
- vi. Annual family Income Certificate obtained from Village Officer, Caste mentioned SSLC certificate or Caste certificate issued by village officer should be produced.
- vii. Name of the student should be included in the ration card produced.
- viii. Students who have secured the following percentage/grades in SSLC/equivalent examination shall be eligible.
- ix. The decision of the KSWCFC with regard to providing financial assistance shall be final.

During the financial year 2024-25, KSWCFC intends to provide scholarships to students belonging to economically weaker families among the forward communities who undergo professional courses viz, CA, CMA (ICWA) & CS.

II. Scope of the Scheme
