ORDER

As per Government Order read as 1st paper above, sanction was accorded for the notification of Crops and Area for Kharif 2023, 24, 25 and Rabi I & II 2023-24, 2024-25, 2025-26 seasons in Kerala under Restructured Weather Based Crop Insurance Scheme (RWBCIS) and Agricultural Insurance Company of India Limited (AICIL) was selected as the implementing agency of RWBCIS in Kerala for Kharif 2023, 2024, 2025 and Rabi I & II 2023-24, 2024-25, 2025-26 Seasons.

2. As per the letter read as 2nd paper above, the Director, Agriculture

Development and Farmers' Welfare Department requested approval for the release of ₹ 5769.81404 lakhs as additional authorisation towards the pending premium subsidy dues for the 1st and 2nd installments for Kharif 2024, and Rabi 2024 under the RWBCIS scheme. The release is to be made under the Head of Account 2401-00-109-65-02 (Plan Voted), and sanction is sought to disburse the amount to the Agriculture Insurance Company of India.

As per Government Order read as 3rd paper above Government have authorised additional expenditure to the tune of Rs.24,14,14,000/- (Rupees Twenty Four Crore Fourteen Lakh Fourteen Thousand Only) under the Head of Account 2401-00-109-65-02 (Plan Voted), to facilitate the payment of first installment of premium subsidy towards the PMFBY/RWBCIS of Kharif 2024 and Rabi 2024.

3. Having examined the matter in detail, Government are pleased to accord sanction for the release and payment of ₹ 24.1414 Crores (Rupees Twenty Four Crore Fourteen Lakh Fourteen Thousand Only) as additional authorisation towards the pending premium subsidy dues for the 1st installment for Kharif 2024, and Rabi 2024 under the RWBCIS scheme, under the Head of Account 2401-00-109-65-02 (Plan Voted).

5. The Director, Agriculture Development and Farmers' Welfare Department is authorized to draw and disburse the amount to the Agriculture Insurance Company of India Ltd (AICIL) during the current Financial Year. An Utilisation Certificate shall be furnished along with the subsequent proposal in this regard.
