**ORDER**

As per the letter read above, the Chief Engineer (Buildings), Public Works Department, Thiruvananthapuram has submitted proposal for Administrative Sanction for the "Construction of Indoor Stadium (Volleyball Court) in Thankamany in Kamakshy Grama Panchayath, Idukki." with a detailed estimate for an amount of Rs. 150 lakhs under the Head of Account 4059-01-051-86 based on DSR 2018 & GST 18%

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work "Construction of Indoor Stadium (Volleyball Court) in Thankamany in Kamakshy Grama Panchayath Idukki district" for an amount of Rs. 150 lakhs, under the Head of Account 4059-01-051-86 subject to the following conditions :

- (1) Technical Sanction Authority shall ensure the construction of building is in compliance with provisions on KPBR 2019.
- (2) The Chief Engineer, Buildings shall ensure that the works proposed in the estimate shall satisfy the functional requirements as envisaged.
- (3) Technical Sanction authority shall ensure the foundation requirements of the building based on detailed soil

investigation done through Government approved agencies having good expertise in this area before issuing the Technical Sanction.

(4) The Structural Design is not seen done for the proposed building.. Hence, the structural adequacy and structural stability shall be ensured before issuing the Technical Sanction considering economy.

(5) Lump sum quantity is provided for reinforcement items for RCC work. Hence, quantity shall be arrived based on the design drawings before according TS.

(6) Lump sum provisions is provided for electrification for an amount of Rs. 5.10 lakhs, hence, detailed estimate shall be prepared before issuing TS.

(7) Technical Sanction Authority shall ensure the correctness of the rates adopted for observed data provided in the estimates and the quality of materials during the time of execution.

(8) The competent authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction.
