ORDER

The Chief Engineer PWD Roads Division had informed that BPCL had deposited rupees 30 Crores for strengthening Chithrapuzha bridge and to construct new bridge parallel to that and for making the Four line road from Chithrapuzha junction to HOC junction in BM&BC standard as per the letter read as 1st paper above. As per the letter read as 2nd paper above, he had submitted proposal for DEPOSIT- Ponjassery -Chithrapuzha road Phase 1 - Construction of New bridge over Chithrapuzha bridge and four lane development from Chitrapuzha Junction to HOC Junction ch 19/940 to 21/940 km for an estimate cost of Rs. 2512.06 lakh (Rupees Twenty five crore twelve lakh and six thousand only) in Kunnathunad LAC using the CSR fund of BPCL.

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work 'Improvement of PWD Road from Chithrapuzha Junction to HOC Junction (2 km) from existing 2 lane to

4 lane, construction of new bridge parallel to Chithrapuzha bridge and strengthening of existing bridge as Phase - I utilizing the CSR fund of Cochin Refineries for an amount of Rs.25,12,06,000/- (Rupees Twenty five crore twelve lakh and six thousand only) in Kunnathunad LAC subject to the following conditions:-

- 1.Possibility of providing uniform thickness in respect of GSB @20cm & WMM @15cm for road widening and bridge approach road works may be explored.
2. The lump sum provisions for utility shifting shall be regulated as per the actual expenditure of concerned utility, and the AS provision shall not be diverted for any other work.
3. As the Road and Bridge works are to be arranged by different Wings of PWD, permission for splitting the work may be issued.
