### ORDER

Government, vide GO read as 1<sup>st</sup> paper above, have accorded Administrative Sanction for the work "Airport Link - Kattambally - Mayyil - Kololam Road" for an amount of ₹15 Crore and then the name of the work was revised to Taliparamba-Chorukkala-Naanicherikkadavu bridge -Mayyil-Chalode Road vide GO read as 2nd paper above. But when the KIIFB accorded Financial Sanction for the above work, one more road stretch namely "Taliparamba Tagore

Vidyanikethan - Allamkulam - Sir Syed College - Bhrandhankunnu Road Km 0/000 to 2/657.31" was also included in the proposal. Therefore, the Project Manager, Kerala Road Fund Board, has requested to issue Revised Administrative Sanction with the new nomenclature "Airport-Link - Improvements to Chorukala - Bavuparamba -Nanicherikadavu- Chekkiyattukavu - Mayyil - Ettayar - Kololam - Chalode Road Km 0/000 to 22/590 and Thalparamba Tagore Vidyanikethan - Allamkulam - Sir Syed College - Brandhankunnu Road Km 0/000 to 2/660 in Kannur District" for an amount of Rs.299,13,93,500/-
