ORDER

Whereas, the Government are of opinion that an industrial dispute exists between 1). the Managing Trustee, Sree Kurumba Educational & Charitable Trust, Anugraha, 30/48, Sreepuram, Poongunnam, Thrissur - 680 002, 2) the Manager, Sree Kurumba Educational & Charitable Trust, Sobha Heritage, Kuruvai Road, Panniyankara (P.O), Vadakkanchery, Palakkad - 678 683 and the workman of the above referred establishment Smt. Sheena Mohan, Paruvassery Veedu, Paruvassery (P.O), Vadakkanchery, Palakkad - 678 686 in respect of matters mentioned in the annexure to this order;

And whereas, in the opinion of Government it is necessary to refer the said industrial dispute for adjudication;

Now, therefore, in exercise of the powers conferred by Section 10(1) (c) of the Industrial Disputes Act of 1947 (Central Act XIV of 1947) the Government hereby direct that the said industrial dispute be referred for adjudication to the Labour Court, Kozhikode. The Labour Court will pass the award within a period of three months.
