<u>ORDER</u>

As per the Government Order read as 1st paper above, Dr. Suja K Kunnath, 573, PNAA, Prasanth Nagar, Medical College. P. O, Thiruvananthapuram was appointed as the full time Executive Director of the National Institute of Speech & Hearing, for a period of two years. She took the charge of Executive Director of the institution on 03.06.2023 and as such her tenure ended on 03.06.2025.

2. In the letter read as 2nd paper above (dated 03.06.2025), Dr. Suja K Kunnath has informed the Government that she has relinquished the charge as Executive Director, NISH, as her tenure in the post has ended.

3. As per the Note read as 2nd paper above, the NISH authorities have informed that, since Dr. Suja K. Kunnath's tenure ended on 03.06.2025, the institution is facing an operational standstill concerning time-sensitive and statutory payments. The institution emphasized the

urgent need to complete transactions vital for its functioning, such as university-related dues, statutory remittances, supplier/vendor payments, and other emergency expenditures, to ensure uninterrupted service to NISH students and clients. Since Dr. Suja K. Kunnath is the authorized signatory for banking transactions, NISH has requested that she be permitted to handle these transactions during the interim period until a new Executive Director takes charge, in the interest of maintaining financial and operational continuity at NISH.

4. Government have examined the matter in detail. In the interest of maintaining financial and operational continuity at NISH, Government are pleased to authorise Dr. Suja K Kunnath, (573, PNAA, Prasanth Nagar, Medical College. P. O, Thiruvananthapuram) to handle financial transactions at NISH until a new Executive Director takes charge.
