ORDER

In connection with the General Election to the Kerala Legislative Assembly, 2026, M/s I-NET Secure Labs Pvt. Ltd., Chennai was entrusted to implement the Webcasting and related services, including Live web streaming, CCTV recording, GPS Tracking of the various activities as per the Agreement read above and consequent to this a Work Order was issued to the firm vide letter read as 2nd paper

above. CEO, Kerala is the Tender Inviting Authority.

On completion of the Elections, M/s I-NET Secure Labs Pvt. Ltd., have submitted invoices for various activities as per the work order. The firm has successfully completed the work. However, upon verification of the submitted Invoices, it is noticed that the firm has executed some works which are not explicitly included in the Work Order. Such works may however be taken up by the vendor if a written request is made by the DEO concerned. Regarding this, an explanation with supporting documents were called from M/s I-Net Secure Labs Pvt Ltd, Chennai, vide letter read as 5th paper above and the firm have produced the same vide letter read as 6th paper above.

After detailed scrutiny of the explanation with the assistance of the Completion Certificates issued by the District Election Officers and the supporting documents produced by M/s I-Net Secure Labs Pvt Ltd, a letter was communicated to the firm informing that the following Invoices/ Activities could not be considered for payment, vide letter read as 7th paper above.

5. Invoice No.2627010, dated 19/05/2026 - Pertains to Live Web streaming of Training Hall activities.
6. Invoice No.2627011, dated 19/05/2026 - Pertains to Live Web Streaming of DEO Control room activities.
7. GPS tracking of VST, VVT and DS Vehicles.
8. GPS tracking of EVM carrying vehicles
9. Live Web Streaming of Postal Ballot Strong Room
10. Live Web Streaming of Counting activities

Now, M/s I-Net Secure Labs Pvt Ltd have raised claims and objections vide representation read as 8th paper above. Further claims and objections may also be

filed. These will need evaluation by a Committee.
