ORDER

As per the letter dated 18.09.2024 read as the 5th paper above, the Additional Principal Chief Conservator of Forests (Admin) has informed the Government that 21 State Forest Service officers had been selected for the IFS cadre, as per the Notifications from the Government of India dated 27.02.2020, 30.09.2021, 17.02.2022 and 28.08.2024 for the years 2016, 2017, 2019, 2020, 2021 and 2022. He has also informed that four officers retired from the Assistant Conservator of Forests post due to superannuation during this period. As detailed above, 25 substantive vacancies are available in the cadre of Assistant Conservator of Forests. Hence, the Additional Principal Chief Conservator of Forests (Admin), as per the letter dated 18.09.2024 read as the 5th paper above, has recommended to the Government to accord confirmation to 25 officers in the cadre of Assistant Conservator of Forests.

2. The Government have examined the matter in detail. As per the Order read as the 1st paper above, confirmation was granted to 20 officers in the substantive vacancies of Assistant Conservator of Forests that arose in the Department after 01.06.2016. Since 4 vacancies were available as of 01.08.2017, B.N. Nagaraj, V. Sajikumar, K.A. Mohammed Zainul Abideen, & K. Saji were appointed as full members, w.e.f 01.08.2017, in accordance with their seniority. Later, following the revision of seniority, as per the

Order read as the 2nd paper above, confirmation was granted to Anaz MA in the cadre of Assistant Conservator of Forests, w.e.f. 01.08.2017.

3. As per Rule 24 of KS&SSR's, a substantive vacancy must be available in the permanent cadre of the relevant class or category for appointment as a full member in that cadre. In that case, based on seniority, the vacancy originally assigned to B.N. Nagaraj should be considered as assigned to Anaz M.A. In that context, K. Saji can be granted confirmation only on 01.09.2017, as the next vacancy occurred on that date. Consequently, the confirmation dates of officers from K. Saji to B. Santhosh Kumar should be revised. In the above circumstances, as per the letter dated 28.10.2024, read as the 5th paper above, the Additional Principal Chief Conservator of Forests (Admin) has submitted a revised proposal to modify the confirmation dates of officers from Anaz M.A to B. Santhosh Kumar. He has also recommended granting confirmation to the 24 officers in the cadre of Assistant Conservator of Forests based on the availability of substantive vacancies. The officers all are approved probationers in the post of Assistant Conservator of Forests.

4. The Government have examined the proposal in detail. The confirmation dates in the cadre of Assistant Conservator of Forests in respect of B.N. Nagaraj, V. Sajikumar, and K.A. Mohammed Zainul Abideen, as granted as per the Order read as the 1st paper above, and in respect of Anaz M.A, as granted as per the Order read as the 2nd paper above, remain unchanged (ie; 01/08/2017). The Government have also observed that, upon revision, the confirmation dates in respect of M. Vimal (sl.no.11), B. Sajeesh Kumar (sl.no.12), Jayamadhavan. A (sl.no.17) and S.R. Radhakrishnan (sl.no.19), as granted as per the Order read as the 1st paper above, will not change. In the above circumstances, the Government are pleased to modify the Order read as the 1st paper above by revising the confirmation dates of following officers in the cadre of Assistant Conservator of Forests.
