ORDER

Government had sanctioned to release an amount of ₹69,92,87,333/- to Kudumbashree as the 2nd tranche of 1st installment of Central share and its matching State share for the implementation of NRLM for the year 2024-25, as per the Government order read as 2nd paper above. Due to insufficient fund in the General component of Central Share of DAY NRLM, an amount of ₹4,53,81,000/- could not be released.

2. Now, as per Government order read as 3rd paper above, an amount of ₹4,53,81,000/- has been re-appropriated to the General component of Central Share DAY NRLM under the head of account 2501-06-198-48-03. In the circumstances, Government are pleased to accord sanction to release the balance amount of Central Share (General component) ₹4,53,81,000/- (Rupees Four Crore Fifty Three Lakh Eighty One Thousand only) to Kudumbashree from the head of account 2501-06-198-48-03 for the implementation of NRLM for the year 2024-25, from current year's budget provision.

3.The Principal Director, LSGD (DDO) shall take urgent necessary steps to get the amount transfer credited to the SNA Account of NRLM in the State bearing Account No. 40251438608 (IFSC: SBIN0070029) maintained by the Executive Director, Kudumbashree.
