ORDER

The applicant, Smt. Shajina Lal, Nursing Officer Gr I filed OA (EKM) 990 of 2024 before the Hon'ble Kerala Administrative Tribunal, Ernakulam aggrieved by the General Transfer order No.EE1/9064/2024/DHS dated 18.07.2024 of the Director of Health Services, whereby the applicant was transferred from Thrissur to Palakkad district.

2. The Hon'ble Tribunal, in its Order dated 23.07.2024 directed the 1st respondent (Secretary, H&FWD) to consider and pass appropriate orders on Annexures A8 appeal at the earliest, at any rate within a period of two months from date of receipt of copy of the order, after affording an opportunity of hearing to the applicant and other affected parties, if any.

3. Accordingly, a hearing was conducted in Government on 13.08.2024, 11.30 A.M. She has contended that she was on LWA for 10 years and the Director of Health Services transferred her on the wrong presumption that she has been serving in Thrissur district continuously for a span of 21 years. So the incumbent was instructed to submit a fresh application covering all the matters pertaining to her service so that the same can be examined at the Directorate of Health Services properly and report to Government.

- 4. Accordingly, the applicant submitted a fresh application referred as 4th paper above. The Director of Health Services has furnished report based on the fresh application. Director of Health Services has reported that Smt. Shajina Lal has been removed from the final transfer list and has been retained in Thrissur district itself.
- 5. In the above circumstances, the grievance of the applicant is redressed. Order of the Hon'ble Kerala Administrative Tribunal dated 23.07.2024 in OA(EKM) 990 of 2024 is complied with accordingly.
