**ORDER**

The Secretary ,Kerala State Indian System of Medicine Self -Financing College Management Association (KISMA) filed WA No.1744 of 2024 against judgement dated 23.10.2024 in WP(C) No 33768/2024 requesting to stay the operation of the judgement dated 23.10.2024 in WP(C) No.33768 of 2024 and direct the 5 th respondent ,Commissioner for Entrance Examinations to invite fresh applications and allotment for the unfilled seats for the BAMS/BSMS/BUMS and post graduate courses following the stipulations contained in Exhibits -P2 & P2(a). While considering the appeal , the Hon'ble Division Bench issued an order dated 03.12.2024, directing the State Government to take a policy decision as contemplated under the extant regulations for fixing the seat matrix for Government Quota ,Management Quota ,NRI Quota etc. The Hon'ble High Court also directed that there should be a proper policy decision regarding the categories of seats among 85 percentage of State Quota seats.In the order , it was also recorded that ,a specific decision as regards the subject matter ,both in respect of 15% quota

which is kept domicile free falling under Clause 3 and the remaining seats be taken .Since the admission close on 20.12.2024 , a decision has to be taken and order has to be placed on record within a period of one week.

2.The apportionment of seats for AYUSH Courses for the academic session 2024-25 was fixed as per Clause I(2), Clause I(3) of the National Commission for Indian System of Medicine (NCISM) directives dated 22.08.2024. As per Clause 3 of NCISM guidelines dated 22.08.2024, the seat matrix for Government Quota , Management Quota ,NRI quota shall be through State /UT Counseling authority and as per clause 4 , management seats under the State /UT Quota in private institutions shall be treated as domicile free. To adhere with the above guidelines, Commissioner for Entrance Examinations , being the State Counseling authority, was given direction to conduct admissions in the management quota seats of Aided /Private /Self financing AYUSH Colleges.

3.Government have examined the matter in detail on the basis of the Order of the Hon'ble High Court dated 03.12.2024 in WA No.1744 of 2024.In compliance with the above order , Government have decided the following apportionment of seats for AYUSH Courses for the 85% State Quota .

Government Quota - 70%  
Management /NRI Quota - 15%

4.The Management/NRI Quota admission Counseling shall be conducted by the Commissioner for Entrance Examinations without any domicile restrictions , as institute level counseling is prohibited , as per Clause 21 of NCISM guidelines dated 22.08.2024.

5. The Order of the Hon'ble High Court dated 03.12.2024 in WA No.1744 of 2024 against judgement dated 23.10.2024 in WP(C) No.33768/2024 filed by KISMA is thus complied with.
