## <u>ORDER</u>

As per the G.O read as 1st above, Administrative Sanction was accorded for the project of Allied Workers' Group Accident Insurance Scheme', for a total outlay of Rs.118 lakh (One Hundred and Eighteen Lakh only) under the Head of Account 2405-00-121-96 (P) .The Chief Secretary level committee meeting convened as per the guidelines issued vide G.O read as 2nd and 3rd above approved the Plan Prioritization proposal in respect of Fisheries Department by limiting the State Plan expenditure of the current financial year to 50% of overall plan outlay of the Department. As per the approved plan prioritization proposal the amount prioritized for the sanctioned project as per the GO read as 3rd above is 118 lakhs itself. Hence as decided in the Chief Secretary level committee Government hereby accord Revised Administrative Sanction for the project 'Allied Workers' Group Accident Insurance Scheme ' in accordance with the Guidelines issued vide GO read as 2nd and 3rd paper above , for an amount of Rs.118 lakh (One Hundred and Eighteen Lakh only) under the Head of Account 2405-00-121-96 (P) in the current financial year.
