### ORDER

As per the Government Order read as 1<sup>st</sup> paper above, Government had accorded administrative sanction for the proposal for Modernization of Slipway of KSINC to facilitate FRP Boat construction and repair at an estimated cost of Rs. 50,00,000/- under the head of account 5056-00-190-77 (plan).

2. As per the letter read as 2<sup>nd</sup> paper above, the Managing Director, KSINC informed that the construction of FRP boat yard was tendered and awarded to the contractor after complying with due procedures. The work is in fast progress and approximately 35% of the work has been completed at site. In order to ensure uninterrupted progress of work and timely completion with in the stipulated period, the Managing Director KSINC has requested the Government to release an amount of Rs.25,00,000/-to the PSTSB A/c No.799012700001721 maintained with District Treasury, Ernakulam.

3. Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹17.5 Lakh (Rupees Seventeen lakh fifty thousand only) to KSINC from the budget provision available under the head of account 5056-00-190-77 (P) for the 'modernization of slipway for FRP Boat construction' subject to the conditions of fund release. Sanction is also accorded to transfer credit the

amount to PSTSB account No.799012700001721 of Managing Director, Kerala Shipping & Inland Navigation Corporation Ltd. Kochi.
