ORDER

The Malabar Cancer Centre (MCC) is an autonomous institution under the Health and Family Welfare Department, Government of Kerala, started with an aim to establish a comprehensive cancer care centre, providing the much-required oncology care to the population of Northern region of Kerala and neighboring parts of Karnataka and Tamil Nadu States. The Director, Malabar Cancer Centre (MCC-PGIOSR) as per his letter read above submitted a proposal for creation of 36 posts on Contract / Temporary basis. As per the said proposal, the construction work of "Treatment and Academic Block" in MCC-PGIOSR, was taken up under KIIFB Phase- I Project, and is nearing completion. The building is envisaged for upgrading the treatment facilities by providing latest amenities for Day Care Chemo and also for promoting academic activities by providing additional class rooms for various courses. It has also been informed that for the smooth conduct of the envisaged activities, additional staffs are urgently required and the matter

was discussed in detail in the Executive Committee Meeting No.89 of MCC, held on 06.06.2024, and the Committee as per decision in agenda item No.89.12 permitted the Director to post required number of staff on contract basis / outsourcing, for the newly constructed Treatment & Academic block,utilizing own funds and also directed to send a request to the Government for creation of the posts.

2. Government have examined the matter in detail and are pleased to accord sanction to create the 36 posts mentioned below, on temporary/contract / outsourcing basis in Malabar Cancer Centre – Post Graduate Institute of Oncology Sciences and Research (MCC-PGIOSR), subject to the following conditions :

(i) the entire recurring financial commitment on account of post creation should be met from the own funds of MCC- PGIOSR and Government grants (plan or non-plan) should not be utilized for the same under any circumstances;

(ii) appointments to the posts should be only on contract / daily wage basis and no regular / permanent appointments should be made.
