ORDER

As per the Government Order read as 1st paper above, Administrative Sanction was accorded for the conduct of "Aarppo-Varayum Variyum Pinnalppam Muhabbathum", by expending ₹42,75,000/- (Rupees Forty-two Lakh Seventy-five Thousand Only) from the H/A: 2235-02-103-80-Gender Park (P), during 2024-2025. As per the Government Order read as 2nd paper above, sanction was accorded for the release of an amount of ₹8,00,000/- (Rupees Eight Lakh Only), under the same head, to settle the pending payments during the 3rd and 4th editions of "Aarppo- Varayum Variyum Pinnalppam Muhabbathum" and to credit the same to the PSTSB A/c. No. 799012700001171 with the District Treasury, Kozhikode.

2. Director, The Gender Park as per the letters read as 3rd papers above submitted proposal for administrative sanction to settle previous payments

for "Aarppo", from the Head of Account: 2235-02-103-80-35-P(V). Director had also submitted that the 3rd and 4th editions of Aarppo was conducted on 06/04/2025 and 06/07/2025, respectively, with minimal resources and limited people, as there was no amount released. For the conduct of 3rd and 4th editions of Aarppo, an amount of ₹1,60,467/- was spent. Even though an amount of ₹8,00,000/- (Rupees Eight Lakh Only) was released as per the GO read 2nd above, as it was towards the end of March, it was difficult to settle the amount before the close of the Financial Year and the amount was resumed. In light of this, Director, the Gender Park had proposed to accord Administrative Sanction for ₹1,60,467/- (Rupees One Lakh Sixty-thousand Four Hundred and Sixty-seven Only) under the head of account 2235-02-103-80-Gender Park (plan) of the current year's budget provision, to settle the previous payments in connection with the 3rd and 4th editions of "Aarppo" conducted during 2024-2025.

3. Government has examined the matter in detail and is pleased to accord sanction for the release of an amount of ₹1,60,467/- (Rupees One Lakh Sixty-thousand Four Hundred and Sixty-seven Only) under the Head of Account: 2235-02-103- 80- 35-P(V) to settle the pending payments of 3rd and 4th editions of the project, by revising the Administrative sanction order issued as per the Government Order read as 1st paper above.
