ORDER

Accordingly, the draft MoU was modified and the revised draft MoU was sent to Ministry of External Affairs as per letter read as 5th paper above. The Ministry of External Affairs, Govt.of India as per Office Memorandum read as 4th paper above, conveyed 'No Objection' for signing the draft MoU between the Kerala Institute of Local Administration (KILA) and the United Nations University Institute on Comparative Regional Integration Studies (UNU-CRIS), Belgium.
