ORDER

As per the G.O. read as 1st paper above, Government have accorded permission to the Director of Medical Education for appointing contract staff through walk-in-interview/ employment exchange for the project "National Programme for Prevention and Management of Burns Injuries" at Government Medical College, Thiruvananthapuram. 2) As per letter read as 3rd paper above, the DME has informed that the term of service of the above staffs has expired and has requested to extend the term of their service for one more year or until the completion of the project, whichever is earlier.

3) Government have examined the matter in detail and are pleased to accord sanction to extend the term of contract service of staffs in Plastic Surgery Wing at GMC Thiruvananthapuram as a part of NPPMBI, as detailed below;

- i. The term of service of Dr. Badusha Thahir.M, Medical Officer, Burns Unit (NPPMBI) under Plastic Surgery wing at GMC Thiruvananthapuram is extended for one more year from 12.03.2026 or until the completion of the project, whichever is earlier.
- ii. The term of service of Smt.Mini.S, Data Entry Operator, Burns Unit (NPPMBI) under Plastic Surgery wing at GMC Thiruvananthapuram is extended for one more year from 04.04.2026 or until the completion of the project, whichever is earlier.
- iii. The term of service of Smt.Bindhya.B, Social Worker, Burns Unit (NPPMBI) under Plastic Surgery wing at GMC Thiruvananthapuram is extended for one more year from 28.05.2026 or until the completion of the project, whichever is earlier.
