### ORDER

As per the letter read as 1<sup>st</sup> paper above, The Government of India has issued a mother sanction for an amount of ₹82,50,000/- (Rupees Eighty Two Lakh and Fifty Thousand only) as Central Share under the Centrally Sponsored Scheme “Capacity Building for Developing Trauma Care Facilities in Govt. Hospitals located in National Highways”(60:40) at Govt.TD Medical College, Alappuzha. As per the letter read as 2<sup>nd</sup> paper above, the Director of

Medical Education has requested to release the central share along with the corresponding state share amounting ₹1,37,50,000/-(Rupees One Crore Thirty Seven Lakhs Fifty Thousand Only) in SPARSH mode for the implementation of the above project and has also requested to accord Administrative Sanction for an amount of Rs.1,37,50,000/- for the procurement of equipment through KMSCL for the trauma care facilities at Government TD Medical College, Alappuzha.

2) As per the G.O read as 3<sup>rd</sup> paper above, Government have additionally authorised an amount of Rs.1,37,50,000/-(Rupees One Crore Thirty Seven Lakhs Fifty Thousand Only) under the Head of Account "2210-05-105-28-07 (PV)" for the release of Central and State share towards the procurement of essential equipment for the Trauma Care Block of Government TD Medical College, Alappuzha for the above project.

3) Government are pleased to accord Administrative Sanction for an amount of **Rs.1,37,50,000/-(Rupees One Crore Thirty Seven Lakhs Fifty Thousand Only)** under the Head of Account "**2210-05-105-28-07 (PV)**" for the procurement of equipment through KMSCL for the trauma care facilities under the CSS project “Capacity Building for Developing Trauma Care Facilities in Govt. Hospitals located in National Highways” at Government TD Medical College, Alappuzha, as per the following;
