ORDER

As per the Government Order read as 1st paper above, Administrative Sanction was accorded for the Annual Plan Schemes of the Kerala Youth Leadership Academy for the financial year 2025-26 at an estimated cost of ₹86,00,000/- under the head of account '2053-00-094-35 (P)'. Out of this, ₹25,00,000/- was sanctioned as the first installment as per the G.O. read as 2nd paper, and ₹25,00,000/- was sanctioned as the second installment as per the G.O. read as 3rd paper above.

2. As per the letter read as 4th paper above, the Director, Kerala Youth Leadership Academy has requested to release the remaining amount for the successful implementation of the annual plan schemes.

3. Government have examined the matter in detail and are pleased to release ₹30,90,000/- (Rupees Thirty Lakhs Ninety Thousand only) as the third installment to the Kerala Youth Leadership Academy under the head of account '2053-00-094-35-00-00-00-P-V' for the financial

year 2025-26, subject to the following terms and conditions:-

- The Director, Kerala Youth Leadership Academy shall ensure that the funds are not parked in Banks/Financial institutions other than treasuries.
- The instructions stipulated in Circular No.75/09/Fin dated 29.08.2009 shall be complied with.
- The instructions in Circular No.84/08/Fin dated 09.12.2008 shall be scrupulously followed.
- The amount should be utilized strictly for the purpose for which it is sanctioned.
- The Director shall transfer credit the amount to a non-interest bearing Treasury Savings Bank Account, and the amount should be drawn according to actual necessity only.
- Any unutilized amount shall be surrendered in the concerned receipt head of account at the end of the financial year.
- The Director shall furnish a detailed component-wise statement of expenditure and Utilization Certificate in Form No. 44 KFC when applying for any further release/settlement.

4. The Under Secretary, General Administration (Co-ordination) Department is authorized to draw the amount of ₹30,90,000/- (Rupees Thirty Lakhs Ninety Thousand Only) from the Head of Account '2053-00-094-35-00-00-00-P-V' and disburse it to the Plan Special Treasury Savings Bank Account (PSTSB Account No. 799012700002272 of Sub Treasury, Vikas Bhavan) of the Kerala Youth Leadership Academy.
