As per the letter read as 2nd paper above, the Chief Engineer, IDRB has informed that in the Arbitration award dated 29.02.2024 by the Arbitration Tribunal, based on 4th Schedule of Arbitration and Conciliation Act, in the DRIP Work "Construction of New Bridge for diversion of traffic for safety of old barrage of Bhoothathankettu", the total fee amounts to Rs. 35,19,849/- excluding travelling expenses and documentation & administration expenses. In the Arbitration award read as 1st paper above it is specified that the fee for the counter claim shall be fully borne by the Respondent, i.e., the department and fixed the fees to be paid by the Respondent/Department to the Tribunal as Rs.26,28,491/-.
