ORDER

As per the letters read above, the Chief Engineer IDRB, Thiruvananthapuram has informed that Financial Sanction and Administrative Sanction were issued by CE, IDRB for conducting preliminary topographic survey of Kadamanthode Irrigation Project for an amount of ₹ 44 Lakh and forwarded detailed estimates for the preparation of DPR for the Kadamanthodu and Thondar dam projects for ₹ 2,52,00,000 and ₹ 2,63,00,000 respectively and requested to issue Administrative Sanction for the works for the effective utilization of 21 TMC of water in the Kabani sub-basin in Wayanad, as per Cauvery award.

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the DPR preparation works of Kadamanthodu and Thondar dam projects for an amount of **Rs 234 lakh (Rupees Two Crore Thirty four lakh only)** by meeting the expenditure under the h/a **4700-80-005-99-02-Investigation of Irrigation Schemes**, subject to the following conditions;

- i. As per CWC norms, the preparation of the Detailed Project Report

(DPR) requires studies on various components which are included in the estimate and obtaining certifications from different departments.

- ii. Expression of Interest to be invited from qualified agencies with wide publicity (within/outside state) for the preparation of DPR.

3. The Chief Engineer, IDRB, Thiruvananthapuram will pursue further action in this matter.
