### **ORDER**

Government, as per the order read 1<sup>st</sup> paper above, have accorded sanction (stage 1) for diversion of 0.48 ha of forest land in Kannur Forest Division for the construction of checkdam across Kuppam River at Lower Cheekkad in Udayagiri Grama Panchayath in Kannur District under Section 2 of Forest (Conservation) Act,1980, subject to the fulfillment of implied conditions.
