In the Budget of 2025-26, an amount of Rs. 50,00,000 (Rupees Fifty lakh only) has been earmarked as grant in aid of to the Centre for Socio-economic and Environmental Studies under the head of account 2202-80-004-84-Non Plan. As per the Government Order read above, administrative sanction for an amount of Rs. 50,00,000 (Rupees Fifty lakhs only) has been accorded to the institution as grant in aid under the head of account 2202-80-004-84-Non Plan for carrying out the activities proposed by its Director for the financial year of 2025-26.

2. As per letter read 2<sup>nd</sup> above, the Director, Centre for Socio-economic and Environmental Studies has requested to release the grant-in-aid of Rs.50 Lakhs for timely implementation of the activities stipulated in the administrative sanction.

3. Government examined the matter in detail and are pleased to release an amount of Rs. 20,00,000 (Rupees Twenty Lakh only) under the head of account 2202-80-004-84- Grant in aid- Non Plan as the first installment of budgetary support to the Centre for Socio-economic and Environmental

Studies (CSES) by crediting the amount to their STSB Account No. 799011400002289 maintained at the Sub-Treasury, Ernakulam.

4. The Director, Centre for Socio-Economic and Environmental Studies shall submit the utilisation certificate and component wise detailed expenditure statement of the released fund before the next release.

5. The Director, Centre for Socio-Economic and Environmental Studies shall also take timely steps to furnish the audited accounts to Government.
