**ORDER**

In the current financial year's Budget, an amount of ₹2,930 lakh (Rupees Two Thousand Nine Hundred and Thirty Lakh only) has been earmarked as budget provision for the Kerala State Science and Technology Museum under the Head of Account 2203-00-112-61-36 - *Grant-in-Aid - General - Non-Salary - P-V*.

2. As per the Government Order read above, Administrative sanction amounting to ₹24,07,82,850 (Rupees Twenty-Four Crore Seven Lakh Eighty-Two Thousand Eight Hundred and Fifty only) has been accorded for the annual plan schemes of the Kerala State Science and Technology Museum for 2025-26 under the Head of Account 2203-00-112-61-36 - *Grant-in-Aid - General - Non-Salary - P-V*.

3. As per the letter read above, the Director, Kerala State Science and Technology Museum, has requested the release of the sanctioned amount for the timely implementation of various plan schemes.

4. Government have examined the matter in detail and are pleased to release an amount of ₹3,00,00,000 (Rupees Three Crore only) as the first instalment of the Grant-in-Aid for the implementation of the plan schemes of the Kerala State Science and Technology Museum for

the financial year 2025-26. The amount shall be released from the Head of Account 2203-00-112-61-36 – *Grant-in-Aid – General – Non-Salary – P-V* to PSTSB Account No. 799012700001438 maintained at the District Treasury, Thiruvananthapuram.

5. The Director, Kerala State Science and Technology Museum, shall submit the utilisation certificate and expenditure statement for the released amount before any further release of funds.

6. The Director shall also take timely steps to furnish the audited accounts to the Government.
