ORDER

In the State budget 2026-27, a total amount of ₹ 278.29 lakh is provided to Institute for Communicative & Cognitive Neuro Sciences (ICCONS) under the non plan head of accounts, '2210-05-105-36-31 - Grant-in-Aid-General Salary' (₹239.18 lakh) and '2210-05-105-36-36-Grant-in-Aid- General - Non Salary' (₹39.11 lakh), for meeting the salary and office expenses of the institute.

2. As per the Government Order read as 1st paper above, 20% of the Budget provision ie; ₹55.658 lakh) of non plan fund for the FY 2026-27, was released to ICCONS as follows;

- ₹47,83,600/- was released under the head of account '2210-05-105-36-31 - (NP) Grant-in-Aid-General Salary'
- ₹7,82,200/- was released under the head of account '2210-05-105-36-36 - (NP) Grant-in-Aid- General - Non Salary'

3. As per the letter read above, the Director (i/c), ICCONS has requested to release the balance non plan fund of ₹222.632 lakh under Head of Account 2210-05-105-36 as the second installment of the non-plan allocation to meet the salary of staff from July 2026 onward and to disburse the gratuity amount due to the retired employees w.e.f.

30.04.2026.

4. Government have examined the matter in detail and are pleased to release a total amount of ₹55.658 lakh, as the second installment of non plan fund for the FY 2026-27 to ICCONS, as follows;

- **₹47,83,600/- (Rupees Forty Seven Lakh Eighty Three Thousand and Six Hundred Only)** is released under the head of account '**2210-05-105-36-31 (NP) Grant-in-Aid-General Salary**'.
- **₹7,82,200/- (Rupees Seven Lakh Eighty Two Thousand and Two Hundred Only)** is released under the head of account '**2210-05-105-36-36 (NP) Grant-in-Aid- General - Non Salary**'.

5. The Director of Health Services, Thiruvananthapuram will draw the amount and release the same to Director (i/c), ICCONS.
