ORDER

As per the Government Order read as 1st paper above, Government accorded Administrative Sanction for an amount of Rs. 25.56 Crore for the proposal of "Setting up of New Dyeing cum Digital Printing Unit at KINFRA Textile Park, Nadukani, Kannur". The Director of Handloom and Textiles, as per the proposal read as 2nd paper above, reported that to ensure effective project execution and reduce the dependency of local cooperative societies on other states for processing facilities, it is now proposed to explore Central Government funding for implementation. For this purpose, funds are urgently required toward the preparation of a revised Detailed Project Report (DPR), further implementation strategies, and related preliminary activities.

2) There is a Budget provision of Rs.10 Lakh for the year 2026-2027 under the head of account 2851-00-103-24 for ' Setting up of Textile Processing Unit at Nadukani'. The Director of Handloom and Textiles has requested to sanction an amount of Rs.10 Lakh for the proposal for Setting up of Textile Processing Unit at Nadukani from the h/a 2851-00-103-24(P).

3) The Departmental Working Group held on 08/07/2026 considered the proposal and recommended for issuing Administrative Sanction for the proposal for an amount of Rs.10 Lakh (Rupees Ten Lakh Only).

4) Accordingly, Government are pleased to accord Administrative Sanction for the proposal for Setting up of Textile Processing Unit at

Nadukani for an amount of Rs.10,00,000/- (Rupees Ten Lakh Only) debiting the expenditure under the head of account 2851-00-103-24(P) from the current year's budget provision.
