ORDER

As per the Order read as 3rd paper above, Government have constituted a Selection Committee comprising of the Chief Secretary, Special Secretary, Environment Department, Prof. K.P.Sudheer, Ex-officio Principal Secretary, Science and Technology Department and Smt. Sindhu.S, Head of the Department, Department of Environmental Engineering, College of Engineering, Thiruvananthapuram to scrutinize the applications received in Government for the post of Member Secretary, Kerala State Pollution Control Board and to select and nominate the eligible candidates as prescribed in the notification read as 4th paper above. The Selection Committee interviewed the candidates on 30/07/2025, and on the basis of the educational qualifications, administrative capacity, experience and performance of the candidates, the Selection Committee ranked three eligible candidates in the order of merit for the post of Member Secretary in the Kerala State Pollution Control Board.

2) Government have examined the recommendation of the Selection Committee in detail and have decided to appoint Dr.Ratish Menon, Nethiamadathil House, Palaparambil Lane, Punkunnam, Thrissur as the Member Secretary in the Kerala State Pollution Control Board as per section 4 of Water (Prevention & Control of Pollution) Act, 1974 with

immediate effect for a period of 3 years.

3) The terms & conditions of the Member Secretary in the Kerala State Pollution Control Board will be as per the provisions stipulated in section (4) of the Water (Prevention & Control of Pollution) Act, 1974.
