**ORDER**

As per the order read as 1<sup>st</sup> above, the Government have accorded sanction to reallocate an amount of Rs.3,32,57,908/- resumed during the end of financial year 2024-25 to the PSTSB account of Kerala Shipping & Inland Navigation Corporation Ltd.(KSINC) which includes an amount of Rs. 21,30,605/- allocated from the head of account under the control of Tourism Department. Later, as per order 2<sup>nd</sup> cited above, the Tourism department has issued separate order for re-allocating the amount of Rs. 21,30,605/- to the KSINC.

In the above circumstances, the total amount of Rs.3,32,57,908/- for reallocation to the PSTSB account of KSINC ordered in paragraph 3 of the Government order read as 1<sup>st</sup> above is modified to Rs.3,11,27,303/- (Three crore eleven lakh twenty seven thousand three hundred and three only) by excluding the amount of Rs.21,30,605/- comes under the tourism department.

3. The Government order read as 1<sup>st</sup> above stands modified to the above extent.
