ORDER

As per the Govt. Order read 1 st paper above, PWD have adopted the online Road Cutting Permission/Right of Way Permission Portal with effect from 01.08.2020 and as per the Order read 2nd paper the restoration works shall be conducted through the existing contractor in cases where there are existing works arranged subject to the specific conditions.

2.The Chief Engineer, Roads as per the letter read above submitted a proposal for modifying the existing conditions mentioned in clause 6(i) & 6(iv) of the Order read 2nd, with additional clauses for the effective implementation of restoration works of the roads through the original contractor. As per the Standard Bid Document conditions, the contractor is bound to execute the extra items and excess quantities required for proper completion of work. The Chief Engineer reported that the rates for excess quantities and extra items including those items required for road

restoration works may be fixed as per terms of contract and prevailing Govt. norms. Since the restoration works arranged as above, are not part of the scope of the original agreement it is reported to be considered as separate work.

3. Government have examined the proposal in detail and are pleased to modify the existing conditions mentioned in the Order read 2nd paper as follows:

Clause 6(i)

Only the provision for Sub grade, GSB and WMM shall be included in the restoration part and shall be optimized. The excess provisions observed in GSB/WMM in road restoration works shall be regulated and should be strictly in accordance with existing guidelines. In case of original works without provision for prime coat and BM, these two items can also be included in restoration estimate part. Also, if damages are caused as part of trenching work to the existing culverts, drain, retaining wall or other road furniture, if any, the items necessary for the restoration of the same shall also be included in restoration part.

Clause 6(iv):

I. In cases where TS rate of original estimate and Restoration estimate are same

a. If same item exists in the original contract -

For such individual items, which exists in the original contract, the rate for restoration item shall be fixed and awarded to the contractor at the quoted rate in original agreement/TS rate of the corresponding item whichever is less

b. If similar item exists in the original contract -

For such similar items, which exists in the original contract, the rate for restoration item shall be fixed and awarded to the contractor at TS rate of

the corresponding item modified with tender variation of the similar item, whichever is less.

c. If item doesn't exist in the original contract (Non similar Items)

In cases, where the corresponding item or similar item doesn't exist in the original estimate, the rate of the restoration item shall be awarded to the contractor at the estimate rate, corresponding to the TS rate at the time of restoration or TS rate of restoration estimate modified by overall tender variation of original agreement, whichever is less.

II. In cases where TS rate of original estimate and Restoration estimate are different

a. If item exists in the original contract (Similar Items)

Contractor's rate may be called for and the restoration work shall be awarded to the contractor at the rate submitted by the contractor or TS rate of the restoration items or TS rate of restoration item modified by tender variation of the corresponding item in the original agreement, whichever is less.

b. If item does not exist in the original contract (Non similar Items)

Contractor's rate may be called for and the restoration work shall be awarded to the contractor at the rate submitted by the contractor / TS rate of the restoration items or TS rate of restoration item modified by overall tender variation of original agreement, whichever is less.

Additional Clause included:

The arrangement of restoration works through the same contractor, shall be limited to only in the cases in which the total EPAC of restoration works does not exceed the EPAC of original work.

Necessary stipulations for the same shall be incorporated in the Notice Inviting Tender(NIT) of the future tenders for road works, if required.

4. The Govt.Order read 2 nd paper above stands modified in this extent.
