ORDER

Government have accord administrative sanction for the construction of Central Custodial facilitation Centre at Kozhikode City with an outlay of Rs. 145 lakhs under the State Plan Scheme 2021-22 as per Government Order read as 1st paper above and as per Government Order read as 2nd paper above an amount of Rs.16,50,000/-was sanctioned for the construction of access road from the main road to the Central Custodial Facilitation Centre Building, Kozhikode City by meeting the expenditure from the current year's budget provision under the head of account 4055-00-207-92-PV. 2)

Thereafter the State Police Chief, as per letter read as 3rd paper above has informed that since the current building of the Kozhikode City Medical College Police Station is in a dangerous condition and the construction work of the Central Custodial Facilitation Center in the vicinity of the Police Station has been completed, the DIG & Commissioner of Police, Kozhikode City has requested that if the basement floor of the Central Custodial Facilitation Center building is slightly modified to suit the functions of the

Medical College Police Station, it can be temporarily transferred to the said building and the building in which the Medical College Police Station is currently operating can be demolished and the dangerous building can be avoided.

3) Although the Central Custodial Facilitation Center building is not directly accessible from the road, it is currently accessible from the west side. Hence the SPC has requested that permission be granted to use the amount of Rs.16,50,000/- (Rupees Sixteen Lakhs Sixty Thousand Only) sanctioned for the construction of access road from the main road to the Central Custodial Facilitation Centre building for the necessary civil, electrical and networking works in the cellar floor (basement area) of the Central Custodial Facilitation Centre building. Only after the completion of this work, the functioning of the Medical College Police Station can be shifted to the Central Custodial Facilitation Centre building.

4) Government have examined the matter in detail and are pleased to **cancel the Government Order read as 2nd paper above** and to accord administrative sanction for an amount of Rs. 16,50,000/- (Rupees Sixteen Lakhs and Fifty Thousand Only) for carrying out civil, electrical and networking works in the cellar (basement) floor of the Custodial Facilitation Centre building, Kozhikode for temporary shifting of Medical College Police Station, by debiting the expenditure from the head of account 4055-00-207-92-PV.
