### ORDER

As per the letter read as 4<sup>th</sup> paper above, the CCRC has proposed an enhancement of the ceiling limit for Non-Plan Heads of Account 2210-05-200-92-00-31-00 (NV) and 2210-05-200-92-00-36-00 (NV) as the funds released so far are nearing full utilization. As per the letter read as 5<sup>th</sup> paper above, the Director of Medical Education has requested the same.

2) Government have examined the matter in detail and are pleased to release an amount of Rs.80,00,000/- (Rupees Eighty Lakh only) under the Head of Account "2210-05-200-92-00-31-00(NV)" to

CCRC subject to the following terms and conditions;

- i) The amount shall not be parked in Banks/Financial Institutions other than treasuries as non interest bearing STSB accounts.
- ii) The instructions stipulated in Circular read as 1<sup>st</sup> and 2<sup>nd</sup> paper above shall be scrupulously followed.
- iii) The Director, Cochin Cancer Center shall furnish duly authenticated detailed component wise statement of Expenditure and Utilisation Certificate in the prescribed form as appended to the G.O read as 3<sup>rd</sup> paper above.
- iv) If there is un-utilised amount at the end of the financial year it should be refunded to the Government during the financial year itself.
