## <u>ORDER</u>

As per the letter read as 2 <sup>nd</sup> paper above, the National Health Mission has requested to refund the resumed fund of Rs.25,11,26,522/- (Rupees Twenty Five Crore Eleven Lakh Twenty Six Thousand Five Hundred and Twenty Two only) and refund an amount of Rs.16,10,15,779/- (Rupees Sixteen Crore Ten Lakh Fifteen Thousand Seven Hundred and Seventy Nine only) which is resumed in the year 2021-22 to the PSTSB account No.799012700000131 of NHM with District Treasury, Thiruvananthapuram.

2) Government have examined the matter in detail and are pleased to release an amount of **Rs.16,73,38,302/-** (**Rupees Sixteen Crore Seventy Three Lakh Thirty Eight Thousand Three Hundred and Two only**) which was resumed in the year 2021-22 to the PSTSB account No.799012700000131 of NHM with District Treasury, Thiruvananthapuram as per the following;

- i. An amount of Rs.12,73,673/- from the CFY BP available under the h/a "2210-01-110-11-Developing Super Speciality Facilities in Selected District/ General Hospitals (P)".
- ii. An amount of Rs.4,69,31,893/- from the CFY BP available under the h/a "2210-01-110-10-Creation of Patient Friendly Hospital Environment (DME) (Plan)".
- iii. An amount Rs.7,82,70,522/- from the h/a "2210-03-103- 90-Developing the Primary Health Centre as Family Health Centre (P)" (Vide G.O.(Rt) No.5371/2024/Fin Dated:08.07.2024, an amount of

Rs.6,82,71,000/- has been additionally authorised under the above h/a in addition to the BP for the reallocation).

iv. An amount of Rs.4,08,62,214/- from the h/a "2210-01-110- 09-Creation of Patient Friendly Hospital Initiative (DHS)(P) (Vide G.O.(Rt) No.5371/2024/Fin dated:08.07.2024, an amount of Rs.2,08,63,000/- has been additionally authorised under the above h/a in addition to the BP for the re allocation).

3) As per the G.O Read as  $3^{rd}$  paper above, Government have additionally authorised an amount of Rs.8,91,34,000/-, inclusive of Rs.6,82,71,000/- under the HoA "2210-03-103- 90-Developing the Primary Health Centre as Family Health Centre (P)" and Rs.2,08,63,000/- under "2210-01-110- 09-Creation of Patient Friendly Hospital Initiative (DHS) (P)".

4) The Additional Expenditure authorised is to reallocate funds resumed from the PSTSB Account of National Health Mission on 30.03.2024. The State Mission Director, National Health Mission shall take timely steps to regularise this additional expenditure through Reappropriation of savings within the Grant / Supplementary Demand for Grants before the close of the current financial year.
