ORDER

The budget allocation for the Pradhan Mantri Jan Arogya Yojana (PMJAY) / Karunya Arogya Suraksha Padhathi (KASP) for the financial year 2026-27 is Rs.9,00,00,00,000/- (Rs 900 crore). Out of the said Budget allocation , Rs.768 crore is allocated under the State Plan, under the H/A 2210-06-800-81 and Rs.132 crore is allocated as CSS under the H/A 2210- 06-800-80(1).

2. As per the G.O read as 2nd above, sanction has been accorded to release an amount of Rs.199.10 Crore from the H/A '2210-06-800-81 PMJAY-KASP-State scheme (P)(V) via IBDS by limiting it to a maximum of Rs.100 Crore per month. In the letter read as 3rd paper above,the Executive Director, State Health Agency has requested to release the state share under AB PMJAY for availing the corresponding central share from NHA share.

3. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.100.90 Crore through IBDS under the H/A "2210-06-800-80(2) PMJAY/KASP State Share-Plan " to the State Health Agency so as to enable timely receipt of the corresponding Central share from National Health Authority.
